

IT IS A NON-INVASIVE SPECIES AND DUE TO ITS ROOTS THAT REACH UP TO 9M DEEP IN THE GROUND IT DOES NOT FEED FROM THE UPPER LAYERS OF SOIL WHERE OTHER PLANTS TAKE THEIR NUTRIENTS.

Thanks to the huge leaves that produce oxygen in large quantities, benefits are also on the environment side.

It also grows in low fertility soils, endures a wide range of acidity (from 5.5 to 8.9) and adapts well to various climatic and soil conditions (at temperatures of -25° C, 45° C and in annual precipitation areas of 1500mm)






